



## Leave A Bequest

*Your bequest is a personal investment in the wellbeing of vulnerable senior citizens. It will sustain PADCA's services into the future.*



# What Is A Bequest?



A bequest or legacy is simply a gift in your Will - a memento or sum of money you wish to leave to whoever, be it a person or organisation you wish to support, show loyalty towards or thank for what they or the organisation has meant for you or your family member.

## This Gift Could Be In Several Forms:

- **A Specific Legacy:**  
this is the simplest form of bequest, naming a specific sum of money. This has a disadvantage of not making allowances for any change in your circumstances, or inflation.
- **Bequeath A Percentage:**  
the advantage of this is that it increases or decreases with your estate. Your other beneficiaries will not suffer from your decision to include PADCA in your Will.
- **A Residual Bequest:**  
after making provision for your nearest and dearest, you can give all, or part, of what is left.
- **A Gift Of Real Estate Or Immovable Property :**  
this can provide income to the beneficiary through rental or sale.
- **An Insurance Policy:**  
an existing policy can be ceded to the beneficiary, or a new policy specifically designed for this purpose.

## A Bequest Is A Gift... Planned And Given...

A bequest to PADCA will help ensure our continuing service to senior citizens.

By leaving a bequest to PADCA you have the unique opportunity of making a valuable contribution to the welfare of the needy senior citizens beyond your lifetime.

## Bequest Form

*This bequest is unrestricted  
and PADCA may use the  
same for the benefit of senior  
citizens in any manner it deems  
appropriate.*

*You may however wish to  
restrict your bequest to a  
specific purpose  
within PADCA.*

**Remember that bequests made  
to PADCA are deductible  
for the purposes of estate duty**
